Pay-it Forward Assistance

This assistance is intended to provide aid to students who have encountered a life event that will prevent them from continuing their education. It is for students who truly want to complete college but, without a hand up, would not be able to. The students who receive this assistance are asked to pay back to the Foundation what they received when they are employed and are able to make the contribution to help other students with similar needs. Funds for this assistance are provided through donations made to the Foundation by faculty, staff and external benefactors.

Licensure & Certification Exam Fee

Financial assistance is available to current students and recent graduates of any Roane State program requiring licensure or certification. Applications for this assistance should be completed by the program director and student and must be approved by the Dean of the Department.

Student Emergency Aid

Emergency aid is available for students who have unforeseen circumstances come upon them in the course of a semester. This could result in an unexpected expense that will keep the student from getting to class; i.e. vehicle break-down, loss of income, etc. The amount of emergency aid will be determined on a case by case basis and is limited to \$500 per student annually. Students requesting emergency aid should be directed to the needs email to begin the process.

Covered: Car repairs, Gasoline, Child Care (limited duration), Utility Bills, Other items as approved

Finish Line Aid

This assistance is available to all students who are in the final semester of classes to complete a degree or certificate at Roane State, have a minimum GPA of 2.0, have extinguished federal and state aid and are not eligible for other assistance to cover their fees. These must be required classes in their program of study. The student must be recommended to the Foundation by a faculty or staff member who is familiar with the student and his/her financial situation.

The Raider Fund

This assistance is available to all students who are in good academic standing. The Raider Fund helps students in need that otherwise do not qualify for other annual or endowed scholarships. By contributing to RSF's General Scholarship Endowment fund ("The Raider Fund"), you will be supporting a variety of scholarship needs for students across the RSCC district.

Food Pantries

There are many students who cannot afford breakfast or lunch and typically spend all day on campus without anything to eat. There are also those that have empty pantries at home. Students who are hungry cannot perform well on tests and are more likely to drop classes or completely withdraw from school. Today, with students learning from home and, in some cases, caring for children and other family members in the midst of this crisis, gifts to the Food Pantry fund make an even bigger difference.
